

Spring Training 2016 Sweepstakes

OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Spring Training 2016 ("Sweepstakes") begins April 1, 2016 and ends May 31, 2016. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into BMI Federal Credit Union's My Finance Tool between April 1, 2016 and ends May 31, 2016, and have added at least one account to their account overview. One entry per household.

BMI Federal Credit Union and contest sponsor – Debtfolio, Inc. dba Geezeo – are not responsible for entries that are lost, misdirected, delayed, destroyed, deleted, erased, stolen, or unreadable. BMI Federal Credit Union and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. Alternate entries are limited to one per household and you MAY NOT send in multiple entries for multiple financial institutions. Eligibility: Entries are open to the general public. No purchase necessary. To qualify for the Sweepstakes, entrants must be a resident of the 50 United States (D.C.), Guam and Puerto Rico and be 18 years or older.

Employees, Board members and consultants of BMI Federal Credit Union and its subsidiaries, and their family members within the same household are not eligible to win.

Selection of Winners: Winners will be chosen by random selection the week of June 6th, 2016, from all eligible entries received during the Promotion Period from all participating financial institutions. There will be a total of five (5) prizes: \$500.00 Grand Prize, \$250.00 first runner up prize, \$100.00 second runner up prize, \$100.00 third runner prize, and \$100.00 fourth runner up prize.

For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

Arbitrator decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT. The place of arbitration shall be in the County in which you reside.
